The following are several cases we engaged in. Do you have similar troubles?

Case One: Taxation Auditing to Avoid Risks

A real estate company in Beijing developed very fast with revenue of more than 200 million yuan a year, but the organ of taxation affairs never did any taxation inspect since it started its business. If there had been any problem in taxation affairs, the company would have great economic and reputation loss. Avoiding taxation risks became the headache of its leadership. Entrusted as its special taxation adviser, Hwuason conducted an overall taxation auditing, and cleared and adjusted all taxation items that had been incorrectly treated. Hwuason also helped the company establish a sound control flow of taxation affairs to fundamentally solve its problem of taxation risks.

Case Two: Special Consultant to Avoid Loss

An American company was planning to merge a large-scale industrial corporation of Hebei. Serving as its special taxation adviser, in the due diligence, Hwuason found that the target corporation was suspected of being involved in evading and dodging huge amount of tax, and this situation had not been exposed. The new American shareholder would have to assume the loss if the purchase was done. Hwuason suggested that the target corporation should first pay the tax before the purchase so as to avoid a loss of several million dollars for the American company.



Case Three: Reasonable Arrangement to Low Tax

A Beijing enterprise's major business was to research, invent and produce environmental protection equipment. Because the products were high-tech ones, the profit and research and invention costs were comparatively high, which led to its very high enterprise income tax. Serving as its taxation planning adviser, Hwuason assisted the enterprise to get recognized as a high technology enterprise and therefore enjoyed the preferential tax rate of 15%. Hwuason also rearranged the research and invention fee to help the enterprise enjoy the cost deduction preferential tax policy, which saved 30 million yuan every year for the enterprise.

Case Four: Tax Adviser to Deal with Inspection

A large Shandong commercial chain enterprise was facing tax auditing, and the CFO knew that some improper tax handling made it difficult to pass the tax inspect. So he hired Hwuason as a special taxation adviser to defuse the risk. First of all, Hwuason assisted the enterprise and the financial officers to conduct themselves and adjust, then made them pay the evaded taxes before the treatment, and enabled the enterprise to pass the tax inspect avoiding the risk of tax administrative punishment.

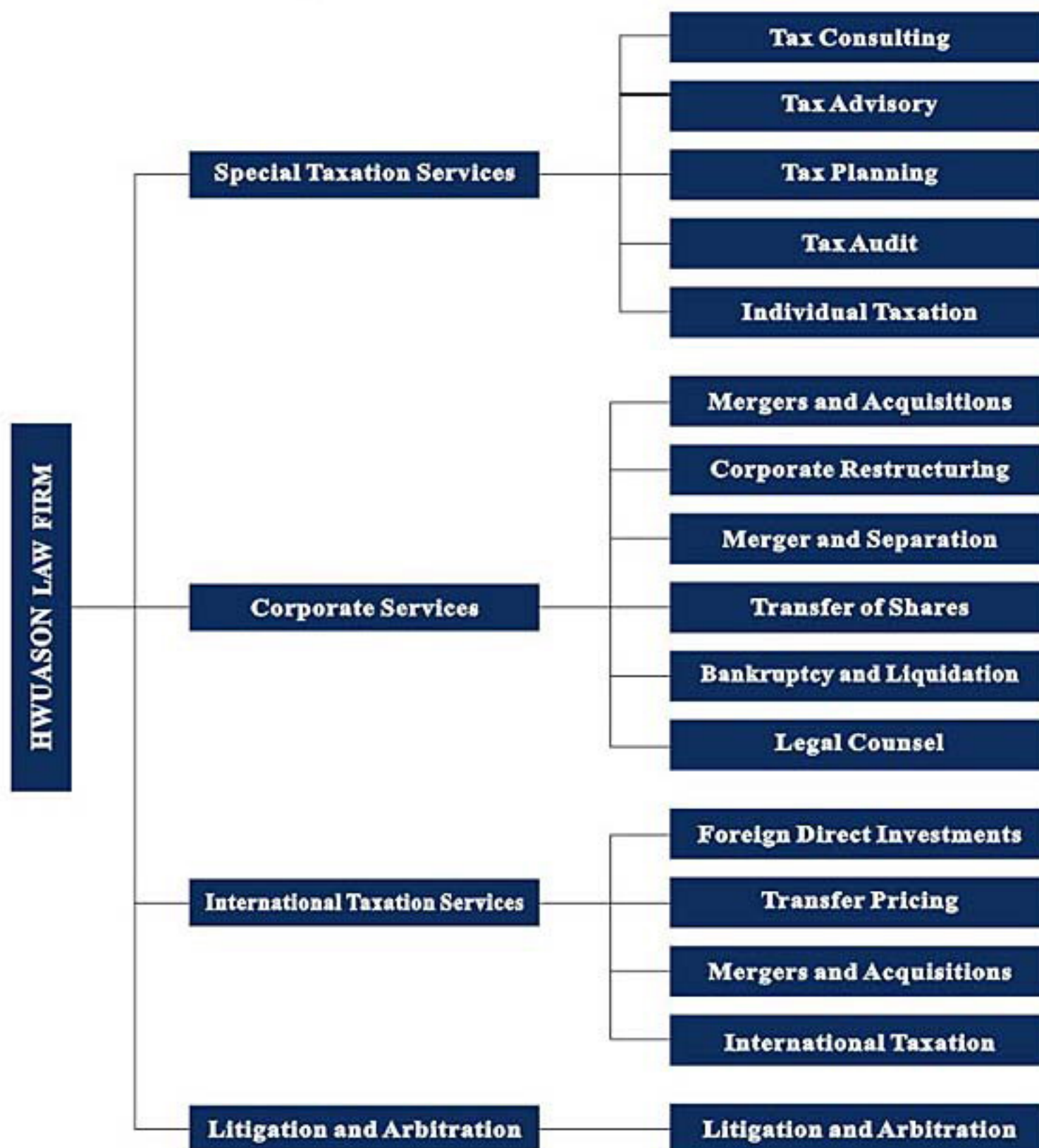
